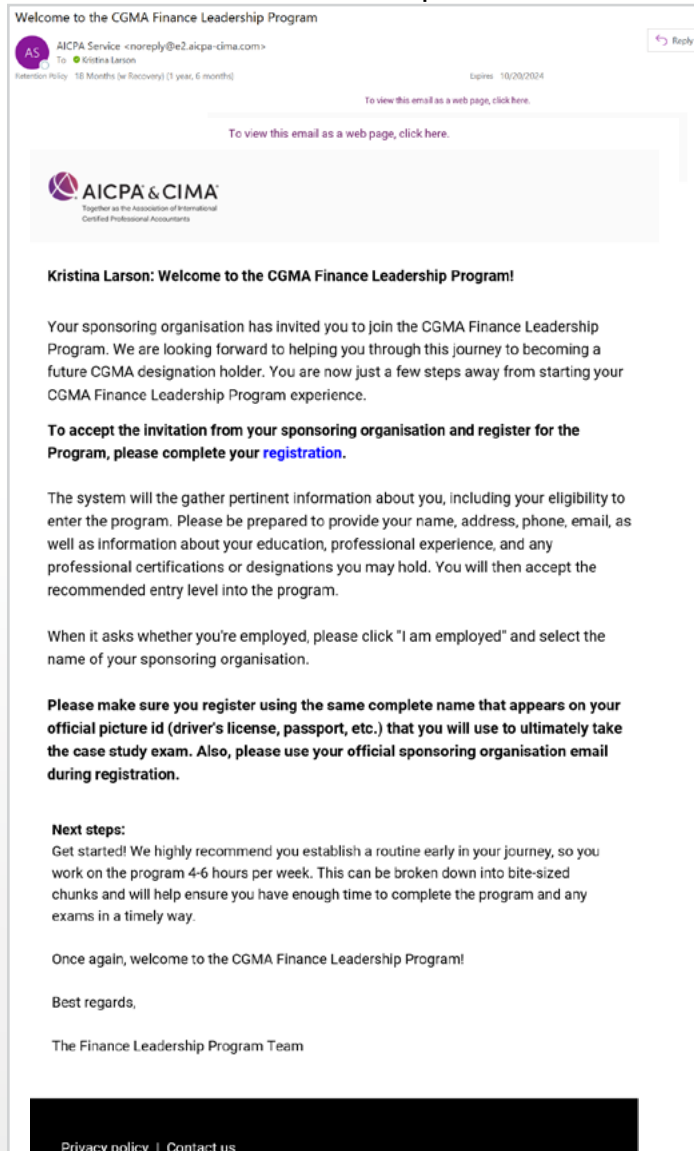

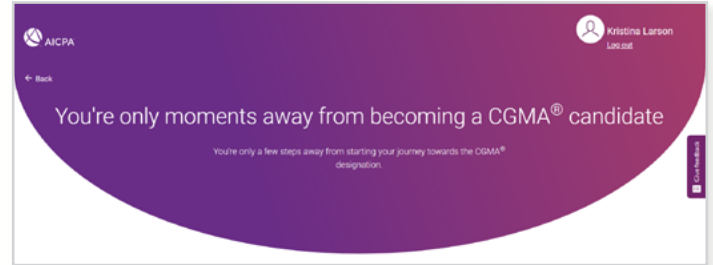
If your sponsoring organization has invited you to join the CGMA Finance Leadership Program, you'll receive an invitation to join.

The email will look similar to this example:

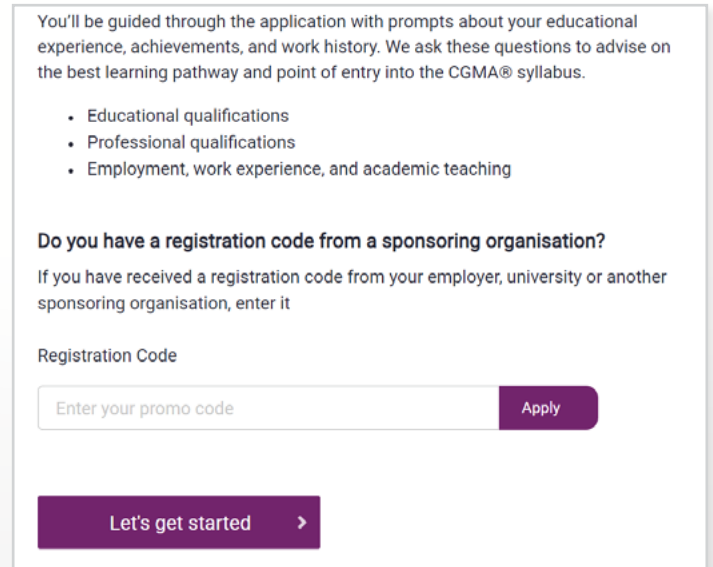


To accept the invitation, please follow these steps:
